**LETTER OF INDEMNITY AND APPOINTMENT**

- makes no representations or promises of guaranteed finance based on any of the products offered unless and until a full unconditional approval is provided in writing from a financial institution.
- states all finance applications require to be assessed on the credit criteria as set out by each funding institution. Its acceptance and rejection will be solely based on the criteria as set out by the finance provider.
- has informed us to obtain our own independent legal advice and/or tax agents advice prior to entering into any finance contract or loan agreement. We understand that it is our decision even if RLG has not informed us to obtain or not to obtain our own independent legal advice and or tax agents advice prior to entering into any finance contract or action on our part.
- has informed us to read the relevant Product Disclosure Statements and or contract.
- its agents and employees will accept no responsibility for any loss in any form that may arise from our actions without RLG's written approval.
- may or may not obtain a financial benefit in the form of brokerage directly from the finance institution or the bank. We understand that RLG will charge us a consultancy fee in addition to any brokerage it may receive for additional work performed. We understand that additional consultancy and professional fees may be charged for all additional amounts financed after the initial contract with the same provider of finance at the same brokerage rates. This will be informed to us based on work performed and time spent prior to any finance approval and after each and every extension contract.
- after obtaining an approval for finance on our behalf, is entitled to charge us a consultancy fee to a minimum of two percent of the value of the finance approval obtained. At the time of settlement the Borrower irrevocably authorises the Lender to pay the balance of the fee due to RLG directly from the loan proceeds. In the event of non-payment you shall be at liberty to lodge a caveat if necessary against properties held by us or our companies to secure payment of the Brokerage / consultancy's fee. We shall pay all reasonable costs incurred in collecting your fee.
- to the extent permitted by law, RLG excludes all express and implied warranties and all liability, whether direct, indirect, special or consequential, arising from negligence or otherwise, illustrations, specifications, product features or other information provided to any person, electronically communicated and or contained on its website. Where, RLG is not permitted to exclude its liability but is permitted to limit its liability, its liability will be limited to the minimum extent possible at law.
- To the extent that RLG's liability is not excluded or is not able to be excluded under these terms and conditions, the total liability RLG may incur in connection with any particular breach of these terms and conditions, tort, breach of statute or breach of any other legal or equitable obligation is limited to, in all cases, at RLG's discretion – one weeks premium or one weeks payment on any given contract or agreement.
